Congratulations: Your submission OpenNCP: a novel framework to foster cross-border e-Health services (Id=299) was accepted as Full paper (Strong accepted) by the SPC.

In **all cases**, please resubmit your contribution as **.doc or .docx** file **in camera ready form no later than February 15th**. If the reviewers comments below require corrections, please correct accordingly, and use track changes when you enter your corrections. You will get notification of final acceptance by **March 1, 2015**. Your registration and payment as delegate has to be received by **March 15th, 2015** (Last day for Early bird rates) in order to ensure your presentation to be part of the program and the proceedings.

Again, carefully check, that you **strictly comply to the required templates** in **all** details ([see here](#)) and do not exceed the 5 page limit for Papers, 1 page limit for Posters, and 3 page limit for Workshops and Panels.

Make sure that all reference are listed in **the Vancouver style** ([see here](#))

Not complying strictly to the size and style will lead to rejection.

In view of new indexing regulations from Thomson Reuters issued after ending MIE2015 submission process, organizers can not guarantee indexing of 1 page posters but the contributions may be presented on classical support during conference.

Contributions submitted and/or accepted as posters may be presented as digipapers on digital media posts supplied by local organizers and have to be resubmitted as 3 pages using full paper layout. If you have submitted a 5 page paper and is accepted as poster, you have to reduce the submission to 3 pages.
